

Public Interest Scholarship Application 2015 Bar Review Courses

Themis Bar Review is proud to offer a Public Interest Scholarship to 2015 graduating law students. Qualifying students will receive their 2015 Themis full bar review course for the jurisdiction of their choice for only \$1195.*

Eligible students must 1) be graduating in Winter 2014 or Spring 2015, 2) be sitting for the bar exam immediately following graduation (February or July 2015), 3) if employed in the public interest sector, have a salary of less than \$60,000, and 4) provide adequate employment verification. If not employed, students must provide documentation of commitment to work in the public interest sector after graduation. Applications must be received no later than April 30th, 2015 at 5:00pm CDT.

To apply for the scholarship, complete the following three simple steps:

- **1)** Register at <u>www.ThemisBar.com</u>. Select your bar review course. Registration with Themis is absolutely FREE with no obligation.
- 2) Submit Form: Complete this form and submit it to Nicole Cleary at info@themisbar.com.
- 3) Verification:
 - a. *Employed Students:* Submit employment verification or acceptance of an offer for employment within the public interest sector. Include brief description of position and salary. Note that judicial clerkships may require additional information.
 - b. *Unemployed Students:* Provide a brief description of your post-graduation employment plans and a resume demonstrating your ongoing commitment to work in the public interest sector as established by one of the following:
 - i) acceptance into an official, law school-sponsored public interest scholarship program,
 - ii) acceptance into an official, non-university public interest fellowship or program, or
 - iii) record of public interest work throughout law school.
